GENERAL INFORMATION

EcoCarbon B is a proprietary blend of boron and carbon designed to help increase nutrient availability in the plant and soil while providing an enhanced version of boron. This product can be used on most fruits, vegetables, field, and row crops.

MIXING

Eco Carbon B mixes well with water with little agitation required. Partially fill tank with water and start agitation. Add Eco Carbon B slowly while agitating. Lastly, add fertilizer product with Eco Carbon B and water.

APPLICATION RATES

SOIL APPLICATION: 0.5 to 10.0 gallons per acre
FERTIGATION RATES: 0.5 to 10.0 gallons per acre
DRIP IRRIGATION: 1.0 to 10.0 gallons per acre, not exceeding 3% solution
FOLIAR APPLICATION: Apply 2-4 quarts per acre

FIRST AID
